

CEDAR CREEK GOLF ASSOCIATION MEETING MINUTES  
1/17/95

The meeting was called to order by President Johnny Molony at 6:04pm. There were 13 association members present and 2 staff members (see attached attendance sheet). The last meeting minutes were read by Charlie Smith and approved as read. Earl Beckam gave the treasurer report. As of 1/17/95, the CCGA has a balance of \$1,351.00 in the treasury (see attached financial statement). There are presently 48 members in good standing in the Cedar Creek Golf Association.

Glen Mosely (past president) indicated that the Cedar Creek Golf Course sign has been installed near the putting green. The sign was made as requested but has a couple of minor items to clear up with the sign maker. The sign is warranted for 2 years. The cost of the sign was \$1,892.10 plus \$100 for installation for a total cost to the Association of \$1,992.10. The Association had originally estimated approximately \$1,700 for the sign about 1 year ago.

Johnny Molony opened the floor to the possibility of a Monday/Friday dog fight. This was based on the fact that there has been approximately 80 new members since the latest membership drive has started, and due to the fact that many areas of SRS will be going to a 4-10 work week. This will result in many members wanting to play golf on either Monday or Friday. Lance Bailey indicated that from the golf course's point of view, if a 1:00pm start time on Friday was selected, tee times would have to be reserved since Friday pm is typically a very busy time. Alan Gregory indicated that an early tee time start would be advantageous to those that like to get off early, yet a 1:00pm tee time would allow others who did not have Friday off work to take a 1/2 day vacation and participate. In addition, the idea of having a poker night was discussed. If a 1:00pm dog fight tee time was implemented, the poker night could start immediately after, say from 5-8pm. The interest seemed to be present, but further evaluation as to the best day and time needs to be made. It was suggested that the pro shop ask members playing in the existing dog fights on Tuesday, Thursday, Saturday, and Sunday if there is an interest for a Monday and/or a Friday dogfight. This issue was tabled until more information could be made available.

Lance showed the new CCGA hats received. They are maroon bill with tan cap covers. The cost will be \$7 each. The 5 CCGA Officers and the past president received a free hat. A collection was taken up amongst all those present to provide a hat to the others at the meeting that are not officers. Enough money was left over for the CCGA to buy a \$5 block in the Super Bowl Pool. The money, if won, would go into the CCGA Treasury.

Cedar Creek Golf Club is no longer under the management of HMS. Based on this, the question was asked whether sponsors may now be able to be obtained to sponsor hole signs. Lance indicated that even though Cedar Creek is under new management, he did not think that the position would change. Lance will check with Neil and report back to the Association at the next meeting.

Lance indicated that he has not heard anything new on the possibility of the new managers installing restrooms on the course. However, Lance did indicate that plans are in place to bring Satellite TV to the clubhouse in February.

Glen Mosely asked if a trip could be planned for the Presidents Day Holiday. Alan Gregory will look into this with Lance.

Charlie Smith suggested that the CCGA determine the project they intend to sponsor in 1995 and make plans early to determine ways to fund the project. Johnny Molony indicated that a remote control color TV has been planned and appointed Charlie Smith as chairman to determine what kind of a TV can be obtained and still fit into the cabinet space in the members lounge. John Bergstrom made a motion seconded by Charlie Smith that a \$500 budget limit be placed on the cost of the TV. The motion was passed. Alan Gregory indicated that he has a VCR that he would be willing to donate to the Association rather than having the Association buy a TV/VCR combination. Charlie Smith indicated that he will provide proposals at the next board meeting. Lance indicated that Wayne Jones indicated that he may have a sponsor that will donate a TV to the Association. Charlie Smith will check on this as well.

Johnny Molony opened the floor to the possibility of a poker night. It was indicated that strict rules would have to be made to limit bets, losses, etc. Alan Gregory suggested that Monday from 6-9pm would be a good time, since then the Monday Night Football could be watched. The poker night would be open to Association Members only. No decision or motion was made at this time.

The tournament schedule for 1995 was reviewed. The following are the dates reserved with the pro shop:

Formats for the Association Tournaments will be determined later.

Rick Boyleston will generate the Cedar Creek Golf Association Newsletter. Chuck Wienke will provide Rick with a copy of the meeting minutes each month for any input into the newsletter. It was suggested that the monthly golf tip from the Golf Professionals, Golf Etiquette, and rules and regulations for the dog fights be included in the newsletter.

Glen Mosely stated that there is a large Coke bottle in the pro shop for a Hole-in-1. Any member who puts money into the Coke bottle and then makes a Hole-in-1 would receive the contents of the bottle. He encouraged each member to participate.

President Johnny Molony adjourned the meeting at 8:19pm.

CEDAR CREEK GOLF ASSOCIATION MEETING MINUTES  
2/21/95

The meeting was called to order by President Johnny Malony at 6:06pm. There were 14 association members present and 3 staff members. The last meeting minutes were read by Chuck Wienke and approved as read. Glen Moseley gave the treasurer report. As of 1/21/95, the CCGA has a balance of \$260.00 (see attached report). Since the last meeting there were no deposits and one expense of \$1,091.10 to pay for the Cedar Creek sign. There are presently 48 members in good standing in the Cedar Creek Golf Association.

Ray Mundy provided the Cedar Creek Staff Report. He indicated that the NCAA Division II Tournament is scheduled to be played at Cedar Creek. The practice rounds will be on May 14 and May 15. The tournament will be held from May 16 through May 19. Ray indicated that he had talked to Mike Carlisle, the golf coach of USCA (the host school for the tournament), who requested assistance from the Golf Association for 15-16 people to be spotters, etc. during the tournament. There will be 18 five-man teams participating along with approximately 5-6 individual regional winners. Ray indicated that the NCAA will determine the rules and provide the course marshalls during the tournament. Based on the rules determined by the NCAA, Ray intends to use many of them as CCGA standard rules in the future.

Butch Dabney, the Cedar Creek groundskeeper, presented some ideas of how Cedar Creek can be beautified. He passed out a proposed scheme (attached) with ideas and costs to add more color to holes #2, #7, #8, #10, and #15. Much of the improvements will be by adding azaleas, dogwoods, and riverbirch plants at strategic locations, particularly near the greens and tee boxes. Butch's handout indicated he could plant approximately 10 dogwoods, 200 azaleas, and 2 riverbirch for approximately \$800. The association indicated that in the future, financial assistance can be provided as appropriate. However, the project for this year so far is to get the color TV in the members lounge.

Ray Mundy indicated that the new scoreboard was used during the recent college tournament held at Cedar Creek. USCA won the tournament by 14 shots! The scoreboard was placed by the deck next to the clubhouse. Ray indicated that there are plans to paint the railing, stain the deck, water seal the deck, and place furniture on the deck in the future to allow the deck area to be used for outdoor activities such as cookouts after tournaments.

Tom Welch indicated that the new stop signs placed on Club Drive were a surprise and that they may be dangerous. The signs are too low and are hard to see in time, there is confusion as to whether they apply to the road or to the bike path, and there appears to be no reason why they were added. It was pointed out that the county did not put the signs up but that they were put up by the Cedar Creek development.

The suggestion was made that the "adopt-a-hole" principal be re-established at Cedar Creek. In the earlier days, members adopted a hole. Once a week they would come and rake the sand, fix all green divots, etc. In return, they would receive a free cart fee. This practice has seemed to falter. Members have commented on how the people who play do not seem to take the time to rake the sand or repair ball marks on the green. Ray indicated that this could be re-established.

Ray Mundy indicated that the pro shop is working on upgrading the yardage books for the course. There will be something available for the college NCAA Tournament in May, but Ray indicated that the pro shop was upgrading the yardages anyway. The question was asked whether the course would be re-handicapped. Ray indicated that it is very difficult to re-handicap a course since it takes many scores from a variety of players. With all the dogfights that<sup>are</sup> being played, the scores posted are not the true scores.

Ray Mundy indicated that the reservations for Masters Week is running approximately 2-weeks ahead of where they were last year. He indicated that the limiting of tickets to the practice rounds has several merchants up in arms and is not sure what affect that may have on players during the week. However, at this time, reservations are going well.

Don Thomas asked whether there will be any Member Appreciation Days this year. Ray indicated that he is allotted a sum of money for support of the membership. Ray's philosophy is to return the money to the members by way of extras during tournaments since not all members may be capable of taking days off during the week to play reduced rates on Member Appreciation Day. Last year Ray indicated that he used the money to provide lower prices to members for tournaments, provided better food for a smaller price, and provided extra prizes for tournaments. The members present agreed that this is a much better way of showing the members the staff's appreciation since it reaches more of the membership.

Charlie Smith reported his findings on the costs of a new Color TV and VCR for the members lounge. Charlie indicated he had talked to a salesman for REX in the Aiken Mall who indicated he would sell the Association a Sharp 20" Stereo Color TV, with remote control, for \$299.99. In addition, he would sell a 4-head Sharp VCR, to go along with the TV, for \$189.00. This would result in a total commitment of \$418.99 total. This package would come with a full 2-year warrantee against all repairs. Ray Mundy indicated that the Association may want to consider buying a TV/VCR through the PGA supply stores. They sell Magnavox units wholesale to golf shops. Ray also indicated that the satellite TV antennae can be installed anytime the club is ready for it. The question arose as to whether more than one TV station can be viewed at a time (with

multiple TVs) without spending more dollars for a splitter unit. Charlie Smith will check with his brother who works for Aiken Cooperative to see if its possible.

Alan Gregory, the tournament chairman, reported that the Kathleen Messura Memorial Tournament is set for March 11. The format will be four-man captain choice. The purpose of the tournament is to raise money, in Kathleen's name, to present to the Cancer Society. Elizabeth Harden, the chairman of the local Cancer Society, printed up the flyers for the tournament, and indicated she will donate 6 Cancer Society Golf Booklets as prizes for the tournament.

Alan Gregory indicated that the CCGA treasury only has \$260 in it as of this date with no fund raisers set until the May tournament. He suggested that in the future, the CCGA fundraiser tournament be held in March and the Kathleen Massura Memorial Tournament be held later in the year to allow the association to raise funds for the yearly project. John Bergstrom suggested that the CCGA consider selling "strings" during the Kathleen Memorial Tournament. The "strings" can be sold in 18" lengths for \$15 or in 24" lengths for \$20. The string can be used by the team to determine if a putt is close enough to the hole to allow a "give me". This is similar to making the rule, "everything within the leather is good" but allows money to be raised to do so. The cost to the 4-man team would only be, at most, \$5. This is the same as the price of a mulligan but could be used by the whole team throughout the entire 18 holes. If there were 20 teams enter, at \$20 per team, the Association could raise \$400 very easily. Mulligans could still be sold as well. No discussion took place.

Alan Gregory made a motion that the Friday dogfight start on Friday, March 3 and start at 12:00 noon. The motion was to have the same rules that apply on Saturday and Sunday govern the dogfight on Friday. Charlie Smith seconded the motion. The motion was carried.

Alan indicated that the months of March, April, and May are fairly full of activities if the association wants to have another tournament, either out of town or at Cedar Creek. Lance indicated that March 24 and 31 were available for a night tournament if desired. It was decided to reserve March 24 for the night tournament. Lance will set it up with a meal starting around 6pm and the tee off at about 7pm.

Charlie Smith pointed out that the golf course needs to stress the dress code. He has observed several players playing in attire not authorized for wear at Cedar Creek. Lance indicated that when they see people who come to play golf who are not properly dressed they mention the dress code to them and ask that they dress properly in the future. The pro shop does not think that taking the




hard line approach is the best way to proceed. Lance indicated that most players who call in to reserve tee times who are new will be told the dress code requirements. Others that show up in inappropriate attire, after being told, usually do not show up in inappropriate attire a second time.

President Johnny Maloney gave his heart felt thanks to all the people who sent gifts, cards, or came to visit him while he was recently in the hospital. It was deeply appreciated.

President Johnny Maloney adjourned the meeting at 8:29pm.

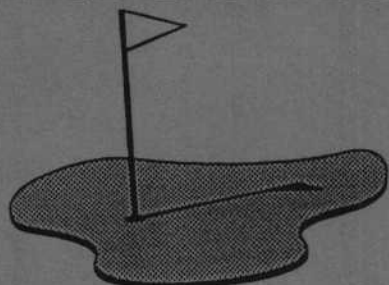

## **Cedar Creek Golf Association Meeting Minutes**

Johnny Molony called the meeting to order at 6:15 pm. 11 in attendance, 10 members and one staff member. (See roster.)

Johnny addressed the agenda to be followed for the meeting (see attached.) The first order of business was the reading of minutes by John Bergstrom. The minutes were approved. Johnny read the treasurer's report (see attached) since I was unable to attend. The Treasurer's Report noted that there was an available balance of \$355 not including the \$660 that was donated to the Cancer Society in Kathleen's name. The reading of the Treasurer's Report and said report were approved.

Johnny Molony noted that the new large screen TV and dish were placed at the club by the owners at no cost to the club. Ray shall secure a sign for the member's room lounge entrance stating that the room is for members only. Those in attendance at the meeting of appreciation shall be forwarded to Ray for his efforts in the new entertainment center. The Association also agreed to forward a letter of appreciation to a Wayne Jones for his kind contribution to Kathleen's tournament.

Alan Gregory discussed the recent tournament held in Klamath Falls noting that a total of 16 teams participated. The net team score was between 57 and 64 strokes. This was accomplished by taking the individual handicap of each team player and dividing that by the number of players on the team. The handicap system used for this tournament will be called Captain's Choice Tournaments.

Discussion continued about the tees to be used for tournaments. It was noted that the blue tees used were not at the front of the teebox. Consideration will be given for future tournaments that the blue tees utilized shall be moved to the front of the blue teebox.

The consensus of all participants in Kathleen's tournament time was had by all. A check shall be issued to the Club for Kathleen's name in the near future.

The next tournament discussed was the night tournament on Friday, March 24, 1995. (See attached form.)

The tournament schedule shall be food service at 6 pm to 7 pm. No mulligans shall be sold for the tournament. The club's staff had requested that each team in the night tournament have at least one club member. Further discussions later in the month, staff members determined that teams may be staffed by members. Completion of the tournament, as was done last year, a raffle Calcutta shall be available for tournament participants.

Alan noted that he would investigate the possibility of sending members out of town trips to Savannah, Georgia and/or Myrtle Beach and/or June. Alan discussed in length the possibilities of Myrtle Beach and the Legends Golf Course complex. This complex has excellent golf courses and on course condos that are available. More information will be made available to the members in the future.

The member/guest tournament is scheduled for the first of July. 7) The format for the tournament will be decided in the future. Possibly a handicapping by total team handicap divided by number of players during the tournament may be a pig picking for Saturday, hamburgers, hot dogs, for Sunday.

In general, the overall dogfight formats were addressed. The 3/19/95 was discussed due to the fact that only 3 tee times were available by the club, but 27 players requested to play. It was noted that participants need to call the club to register.

Also discussed was the use of white and blue teeboxes during the dogfight. Some members requested that all players be assigned to a specific teebox.



only one tee box while playing the par three holes. A motion was made by Alan Gregory to accept this suggestion. Doug Snyder seconded the motion. The motion was defeated unanimously.

The Friday dog fight starting times (11:52, 12:00 and 12:08) should be moved to an earlier time frame (start 8:00 am). This was suggested because of the extended playing time, 4-1/2 to 5 hours, due to the increased heat during the summer.

General concerns about overall slow play on the golf course were noted by the membership. It was determined that the club staff was responsible to review and address all concerns and solve the slow play problem.

Glen Moseley discussed some member suggestions regarding the dogfight. It was noted that some participants in the dogfight like to have all scores above .5 raised to the next whole number. Some of the members present discussed their feelings and concerns regarding this suggestion. A large portion of the members attending the meeting felt that the next whole number would allow for an inordinate number of ties and would require some means to break these ties. After all input was received, Alan Gregory made a motion to change all scores above .5 to the next whole number. Gregory seconded the motion. The motion was defeated.

The next item Glen discussed was concerns noted by the membership that some individuals are playing through when the ground crew is working to maintain the course. It should be noted that when the ground crew is working, the flag from any green that is a signal for all players to stop play is the flag on the ground crew if finished with their work. The membership agreed that if they observe any of the above noted items, they should inform the offenders to abide by these rules. It also must be noted that the Golf Association was formed to assist the Club's staff in maintaining the course enjoyable for all participants but that the overall responsibility for the supervision of all play on the course resides in the club's staff.

The club's staff was represented by Hoffie (Ray was at 1 meeting). Hoffie discussed the current power built tour. He noted that <sup>KEVIN</sup> ~~Eric~~ Radcliffe was only four shots behind in sixth place. The staff asked that all Cedar Creek Golf members advise any players observed not abiding to the taking golf carts inside roped off areas to please abide by the carts to outside the roped areas. Presently there are signed up for the night tournament that is scheduled for 3/24/95. It was noted that the reservation of tee times are running about the same as last year. Any members during master's week shall need to contact the club's staff times.

John Bergstrom noted that the Coker College baseball team a fund raiser golf tournament (see attached) at Charleston course on June 10, 1995. Closing date for entries will be format for the tournament would be a four man captain's two available team openings at this time. This tournament being incorporated with previous discussions concerning Charleston to play at Crowfield Plantation Golf Course. on this trip will be discussed at the next Association meeting.

There being no other meeting business, President Johnn meeting at 7:43 pm.

5/16/95

The meeting was called to order by President Johnny Malony at 6:13pm. There were 12 association members present and 2 staff members. The last meeting minutes were read by Chuck Wienke and approved as read. Earl Beckham gave the treasurer report. As of 5/16/95, the CCGA has a balance of \$915.00 (see attached report). There are presently 74 members in good standing in the Cedar Creek Golf Association.

Glen Moseley brought up a few items that need to be brought up with the Cedar Creek Golf Club Staff. They included a request to ensure that the dog fight on Saturday be as early as possible to ensure as few groups as possible are in front of the dogfight. 6/20/95

The meeting was called to order by President Johnny Malony at 6:01pm. There were 10 association members present and 1 staff members. The last meeting minutes were read by Chuck Wienke and approved as read. Earl Beckham gave the treasurer report. As of 6/20/95, the CCGA has a balance of \$776.74 (see attached report). There are presently 75 members in good standing in the Cedar Creek Golf Association.

Tom Welch provided the Cedar Creek Golf Association with an second \$85 donation to be put towards the purchase of blinds in the member lounge.

Ray Mundy provided the staff report. The Oldsmobile Classic Golf Tournament, local play, will be held at Cedar Creek on July 8. Flyers were sent to all members in the most recent mailing. This will be a 4-man scramble. Two of the team members must be members from Cedar Creek and all players must have a USGA established handicap, no exceptions. If at least 56 players participate, the team with the best score gross and the team with the best score net will advance to the regional play at Wildwood Golf Club in Columbia on August 8. 7/18/95

The meeting was called to order by President Johnny Malony at 6:15pm. There were 14 association members present and 1 staff members (see attached attendance list). The last meeting minutes were read by Charlie Smith and modified as follows. The Oldsmobile Classic Regional Tournament will be on August 7th and not August 8th. The Club Championship will start at 8:00am and not 9:00am. The minutes were accepted as amended. Earl Beckham gave the treasurer report. As of 7/18/95, the CCGA has a balance of \$893.74 (see attached report). There are presently 75 members in good standing in the Cedar Creek Golf Association.

Ray Mundy provided the staff report. There has been a good turn out for the Club Championship. So far 67 members have signed up. Ray indicated that Jim Hoff from Black Creek has offered Cedar Creek members a challenge on August 18 & 19. Jim and several of his members will come to Cedar Creek to challenge some of Cedar Creek's members. Ray will work out what type of challenge will be held later. Ray indicated that for the Club Championship, they will probably not have different tee boxes for different flights. Since flighting will be after the first day, some members could end up using different tee boxes the second day which could be confusing. Also, a longest drive or a chipping contest will probably be held. More than likely a chipping contest. This will end up with hopefully more individuals participating. This contest would probably be held on Saturday after completion of the round. Ray indicated that there will not be any additional charge for the event so as to encourage more participants. John Bergstrom suggested that some of the prizes being received from manufactures be used to award winners of the chipping contest. In addition, it was suggested that since all participants were members, that prizes could be free cart fees. Since play will be continuing on the course, it was suggested that the chipping contest be held on the practice green or the driving range. The starting tee time on Sunday will be 10:00am.

Alan Gregory gave the Tournament Director's report. A trip to Glassy will be set up for August 25th and 26th. This will include Vale of Glassy, a new course. It was stated that this would be a good opportunity for our members since this course will not be open to the public in the future. Ray will set up the tee times. On October 14th, Alan is setting up an outing at Traces. This should be a good date since Clemson and Carolina will both be out of town. This could be a two-day event. If this cannot be arranged, Alan indicated that he would try to set up something in Myrtle Beach. Ray Mundy suggested to "head for the mountains" in August and go to the beach in November/December.

In the general discussion, Johnny Maloney stated that the CCGA has followed up on Wayne Jones' recommendation to solicit sponsors for the Club Championship. Letters were sent to 30 manufacturers. To

date, we have received 1 response, 3 shirts from Divots. Divots also requested that we display their banner during the tournament. J. D. Baston is working on some kind of tournament between Jones Creek and Cedar Creek on August 26th and 27th. This will be a qualifier for a Golf Fantasy package to Las Vegas later in the year. The tournament will consist of two man teams of which one must be a member of the parent club. This will be a two day event with teams qualifying on both days. One day will be played at Cedar Creek and the other day will be played at Jones Creek. Ray Mundy indicated that the summer has not been good to the course. Lighting in the evenings has hit the irrigation system several times and the greens are just starting to come back despite all the rain we had. The greens have been slower lately due to the fact that they have to let the greens grow to recover. Ray also indicated that Butch is also trying to get some of the mounds cut down on the greens. Ray also indicated that no decision has been made as to overseed the fairways this winter. If looks are important, spraying them green was suggested, since the fairways are better now than they ever have been due to not overseeding last year. Not overseeding will result in brown fairways for maybe 3 months but it will also allow the grass to grow faster and thicker sooner when the weather turns warmer.

The association has set aside \$170 to buy blinds for the members lounge. Ray stated that an off white color would be most acceptable to go with the club house trim.

President Johnny Maloney adjourned the meeting at 7:00pm.

Johnny Maloney made a proposal to make the Sunday dogfight to an all-day affair later on. This must be voted on.


Finally, Alan Gregory indicated that the final end-of-the-year tournament will be on December 2. More will come later.



MEETING MINUTES OF 12/2/95

The meeting was called to order by President Johnny Maloney at 4:05pm. There were 21 member and 1 staff member present. The previous meeting minutes were read by Chuck Wienke. Corrections were made to identify the winners of the recent night golf tournament. The meeting minutes were approved as modified. Earl Beckham provided the treasurers report. As of 12/2/95, the CCGA has \$1,120.02 in the treasury.

Charlie Smith stated that the blinds recently installed in the members lounge were purchased from Home Owners Warehouse and that they are of superior quality.

Alan Gregory provided the tournament directors report. He indicated that a trip to Myrtle Beach is still being planned for the weekend of the Super Bowl. Alan will pass whatever information he has on to the next tournament director. Alan indicated that some of the cost for this tournament will be supplemented by the CCGA. President Maloney thanked Alan for his work as tournament director this year.

Ray Mundy gave the staff report. The end of the year tournament just completed had 24 players (12 teams). Ray indicated that approximately \$215 was taken in for mulligans that will be passed on to the CCGA. Ray thanked all those that played. Ray indicated that the Cedar Creek Golf Club is still approximately at the membership level that they want to be at. Membership initiation is still \$250 at this time. There does not appear to any move in the near future to lower it to increase memberships. Ray indicated that the club will receive a new shipment of E-Z-Go carts soon. Ray indicated that with all the recent reports in the newspaper that Cedar Creek has been sold does not have any affect on the golf course. Nothing has changed as to who owns the golf course. CCGC members that are not residents of Cedar Creek still are not able to play on the tennis courts and swim in the pool however. This is mainly due to the liability of the Cedar Creek Homeowners Association. President Maloney and the entire Cedar Creek Golf Association thanked Ray and his staff for an excellent golf year and for the best golf course in the area.

Wayne Jones and John Bergstrom gave the report on the evaluation conducted on possible dogfight rule changes. John indicated that the committee looked at other clubs and how they handle their dogfights. Many are using 4-man teams where every team would have a target score to accomplish based on the points they are to pull collectively. Then the winners would be based on which team came in with the best scores as compared against their target score. John also indicated that prizes were given for low gross and low net. This type of format would encourage the better golfers to play in the dogfight, something that the present dogfight does not

do. For the CCGA to use this type of format, the CCGA players would have to show up early (30 minutes) in order to pick teams. It was proposed that the best golfers present that day (based on the number of golfers who are playing) would chose the teams. This could be done on a trial basis for the time being if desired on either saturday or sunday or both. The problem on saturday would be getting tee times that agree with everyone. Alan Gregory made a motion that this 4-man format dogfight be instituted on a trial basis, for the month of January, on Sunday afternoon only and that at the ~~January~~ meeting the acceptability of instituting it permanently on saturday and sunday be determined. The motion was seconded by Billy Maloney. The motion was passed with one dissenting vote. It was decided that the players must notify the club by Wednesday if they want to play. The dogfight will start at 1PM and players should show up no later than 12:30PM unless they call ahead that morning and verify they will be there to play but not until 1PM. They will be assigned a team as if they are present at the 12:30PM team selection.

The next order of business was to elect next year's officers. The slate as determined by the nominating committee included Charlie Smith as President, Chuck Wienke as Vice-President, Earl Beckham as Treasurer, Stan Black as Secretary, and Wayne Jones as Tournament Director. The club received 2 absentee ballots with no new nominations. The request was made for nominations from the floor to which there were none received. Alan Gregory made a motion that the slate of officers presented be accepted as next years officers. Glen Moseley seconded the motion. The slate of officers as proposed were accepted by all those members present.

Johnny Maloney stated that the Association is sponsoring a Christmas Party for saturday evening, December 15 from 6-9PM. There will be heavy O'douves and the pro shop will be open with special prices to make those christmas present purchases. A notification will be coming in the December invoices with a request to RSVP by December 12.

Charlie Smith encouraged all those there to attend the Association meeting on the 3rd tuesday of every month and to notify all those members they know to do the same. The attendance at these meetings has not been too bountiful.

Wayne Jones, next years tournament director, requested all those who have suggestions on the type of tournaments that the members would like to have next year to let him know. In addition, he asked for the type of trips and special outings that the members would like to see next year.


Charlie Smith thanked Johnny Maloney for a great year for the association under Johnny's leadership. Johnny did a wonderful job.

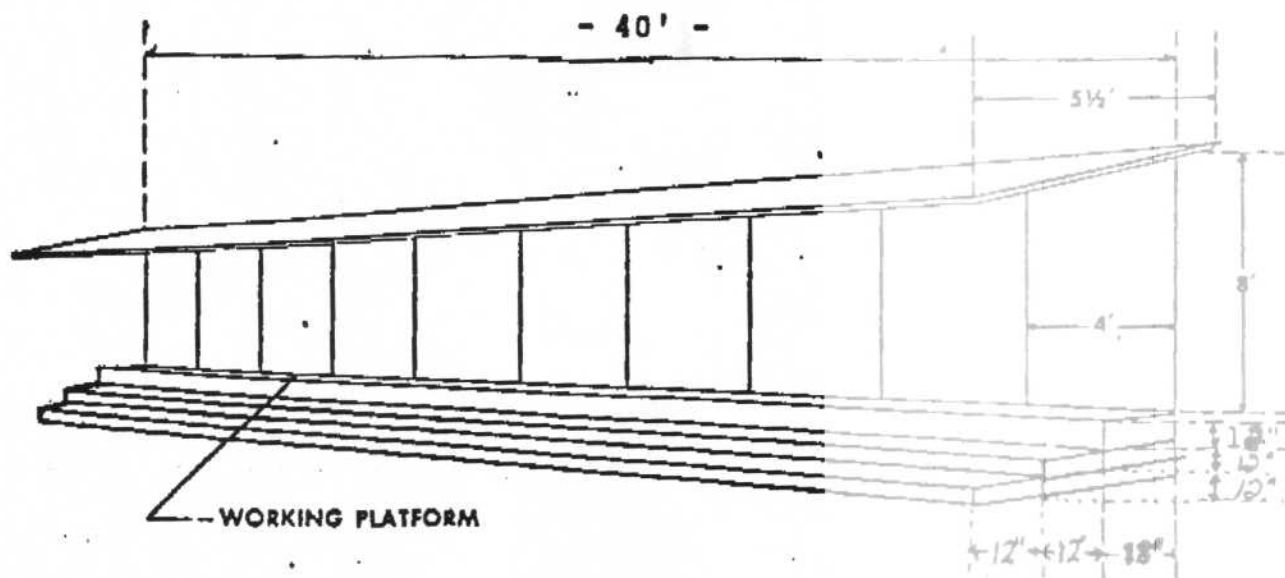

### OUTSIDE HOLE-BY-HOLE SCOREBOARD

The outside scoreboard should be located in an area near the 18th green that is in public view, but at the same time, does not interfere with play. In locating the scoreboard, it is important that it face Northeast and that its front is not obstructed from public view by trees, concession stands or tents.

Detailed below are the plans for the construction of the scoreboard.



In building the official scoreboard, please be careful to observe the following:

1. 4" x 6" lumber must be used for the framework of the scoreboard and all braces.
2. 2" x 12" boards must be used for the working platform. There should not be any gaps between each board and the face of the scoreboard.
3. 4' x 8' plywood at least 1/2" thick should be used for the scoring surface. Please be sure the scoring surface is flush with the working surface of the platform. In addition, please be careful that the scoring surface is free of all

## BYLAWS

### ARTICLE 1. MEMBERS RIGHTS AND PRIVILEGES

Any member with dues paid up to date shall be considered in good standing and shall be entitled to vote at all meetings of the association and participate in all events upon compliance with all adopted regulations.

### ARTICLE 2. ELECTION OF OFFICERS

Section 1. The election of officers shall be held annually at the December meeting of the association. New officers take over the first of January of the next year.

Section 2. The President shall appoint a nominating committee consisting of three members of the association to solicit nominations and prepare a ballot consisting of a least one candidate for each elected office sixty days prior to the annual meeting. Thirty days prior to the annual meeting the above slate will be published. Nominations may be made from the floor provided the persons nominated have agreed to accept the nomination.

Section 3. Voting must be done by ballot or absentee voting by proxy, signed, sealed and delivered to the nominating committee.

Section 4. The term of office shall be for one year, beginning January 1 and ending December 31 of the calendar year following the election.

Section 5. In the event of a vacancy on the Executive Board, the President shall appoint, with the concurrence of the Board, an officer to fulfill the remainder of the term.

### ARTICLE 3. DUTIES OF OFFICERS

Section 1. It shall be the duty of the President to preside at all meetings of the association and to appoint special committees. The President shall serve as an ex-officio member of all committees and serve as liaison with Cedar Creek Golf Club management.

Section 1. The Vice President shall serve as President in the absence of the President.

Section 3. The Secretary shall keep a record of all meetings and take care of all correspondence. The records are to be turned over to the new Secretary at the beginning of a new year.

Section 4. The Treasurer shall receive and disburse all funds of the association subject to the approval of the association. He shall be required to present a written report of the financial status at each Executive Board meeting and to present a written financial report in December showing all receipts and expenditures during his term of office.

Section 5. The Tournament Director shall be responsible for planning and conducting all competition of the association. He shall prepare and coordinate a schedule of events that will be distributed to the members of the association.

ARTICLE 4. DUES

The dues for each member of the association shall be five dollars per calendar year, beginning in 1993.

ARTICLE 5. TOURNAMENT RULES

Section 1. The association will play golf according to the USGA Rules and such local rules as are published for the course being played.

Section 2. Score cards must be signed, dated and attested and turned in to the scorekeeper after each tournament or members will not be eligible for prizes.
