CCGA Board Meeting  
January 4, 1999

1. The first meeting of 1999 was called to order by our new President Johnny Molony on Monday, January 4th @1835.
2. A warm welcome to all guests (see attached roster). 23 members present.
3. An introduction of the 1999 officers was made by our President Johnny Molony.  
President: Johnny Molony  
Vice President: James Gregory  
Secretary: Kathy Cornforth

Chairman of Board: Wayne Jones  
Tournament Director: Burt Wronsky
4. Johnny Molony reported that we have 69 members as of 1-4-99.
5. Johnny Molony gave the treasurers report: Earl Beckham, last year's treasurer, not here to give the check book to our new treasurer. Johnny Molony reports that we have approximately \$1837.97.
6. Staff Report: Lance Bailey spoke on course play goal of being 33,000 rounds for this year.  
Upcoming events: Par 3 tournament on Saturday, 1-23-99 @ 0900; shotgun start.  
Randy Richardson asked Lance to remind us about frost delays and to please be patient.  
A reminder from Cedar Creek Properties about stop signs and speed limit on club drive.  
Lance shared a Christmas card received from Tom Welch.  
Alan Gregory asked Lance to inform Randy of leaking sprinkler on #13. Dick Sparks said a sprinkler on #10 was also leaking.  
Joel Peecook told Lance that #3 white tee box needs repairing.  
Comments from others about this tee box was made.  
Lance will pass on these concerns to Randy Richardson.
7. Tournament Director's Report: Burt Wronsky  
We need to lock in dates with the club while they are still open for our special tournaments. CCGA sponsors at least 4 tournaments/year; 1 per quarter. Discussion took place with Lance on available dates.
  - A. The Annual Meeting and Golf Tournament is always the first Saturday in December: Sat., Dec. 4, 1999.
  - B. The Member/Guest Tournament  
Sat., May 29 and Sun., May 30, 1999.

C. The Club Championship

Sat., Aug. 7 and Sun., Aug. 8, 1999.

D. The Kathleen Messura. This tournament raises money for the American Cancer Society. No date decided at this time. The week after Masters was suggested by ~~Kenneth~~<sup>Keith</sup> Sizemore. Lance said this week was too busy for the club and suggested maybe a date in May.

E. The Houston Lovelace Tournament: No date decided.

\*Mike Cornforth suggested that we have a Night Golf Tournament.

\*The tournament committee will come up with the format and dates for other tournaments.

8. Old Business: Wayne Jones thanked everyone who served last year.

9. New Business: Open Discussion from the floor.

A. Dick Sparks expressed interest in having Senior Tees. Doug McLane and Joel Peacock said that some holes are too long to reach from the white tees. Lance said that senior tees are just behind the front tees or red ladies tees and they could be used as senior tees.

B. Doug Snyder commented on the Dog Fights taking too long and ways to speed up play.

1. Continuous putting, putt out
2. Gimmies; inside the leather
3. Keep long grass cut in rough, hard to find ball.

\*Other suggestions from the floor to speed up play:

1. When out of the hole.....pick up your ball.
2. Shotgun start

\*Lance commented on what's acceptable for the pace of play.

\*Billy Bray suggested to have 4 clocks on the course, on #5, #9, #14, #18. He said you should spend no more than 15 min. per hole.

\*Rocky Oswald suggested that when it is cart path only and your ball is on the other side of the fairway, take an extra club with you.

\*Mike Cornforth commented on the way Reynolds Plantation controls the speed of play. The starter documents the time you start on a board with a wax pencil; at the turn, you are timed by the ranger and he lets you know how you are doing.

\*Randy Odom suggested to keep up with the group in front of you.

\*A proposal was made by Doug McLane to speed up play:

- A. Continuous putting, putt out
- B. Gimmies, inside the leather

The proposal was second by George Ferko. The proposal will be discussed and voted on at the next meeting. Several members were against the gimmies.

\*Joel Peecook proposed to penalize the 4-some 2 strokes each if they finish longer than 20 minutes to the 4-some in front of them. Several members commented & disagreed with this proposal.

C. Other Concerns: James Gregory was concerned about the absence of some grass around the edges of some of the greens. Lance commented that it may be some algae causing this, but Randy is keeping a close watch. James also commented on the increase in dues and cart fees for 1999. He said he could understand about the dues, but the carts are way above the other courses in the area. Also, outside players paying the same rates as members. Lance could not give a good explanation; he brought up about having new carts and said he would talk with the owners of the club concerning the cart fees for members. Glen Mosely commented on comparing members rates with non-member rates.

D. Several members suggested to Lance to remove the OOB by #3 green or to move it back. Lance will take a look at this.

Meeting adjourned @1935. Motion made by Doug Snyder, second by Otis Beard.

Several members stayed after the meeting to watch the National College Football game between Tennessee and Florida State on the big screen TV. We ate some delicious chili prepared by the Cedar Creek Grill.

CCGA Board Meeting  
February 1, 1999

1. The meeting was called to order by our president, Johnny Molony on Mon., Feb. 1 @ 1831.
2. Johnny Molony welcomed all guests (see attached roster, 16 members present). Two new members were introduced:
  - A. Harvey Foulkes: Harvey is the new President of the Senior Golf League for 1999.
  - B. Ron Phillips -
3. The minutes for the January meeting were read by our secretary, Kathy Cornforth. Johnny Molony corrected one mistake, which was an incorrect first name; Keith instead of Kenith Sizemore. The correction was made and the minutes were approved by all members. Johnny Molony commented on my thorough minutes and thanked me for doing a good job.
4. Treasurer's Report: Our treasurer, Keith Sizemore gave his report. Keith reports that we have \$1585.75 as of Feb. 1, 1999. A detailed report is available for you to review. Our notebook is stored in the Member's Only Lounge with this information. Johnny Molony reports that we have three people authorized to sign checks. The primary person is Keith Sizemore and the other two are Johnny Molony and James Gregory.
5. Staff Report: The staff report was given by Lance Bailey. Lance, Huffy, and Dana went to Orlando, FL to the PGA Golf Show and saw some new golf equipment.
  - A. Calloway Hawk Eye Wood
  - B. Adam Driver, designed by Nick Faldo
  - C. Nike Golf BallDana got a five minute putting lesson from Ben Krenshaw at the golf show. Lance reports that aeration of the greens will take place on May 18. This will conflict with the Member/Guest Tournament so we will change the Member/Guest from May 29th and 30th to June 5th and 6th. The OOB on ~~#6~~ <sup>#3</sup> has been moved back. Randy and his crew are putting steps in on #7 Green. They are putting color coordinated blocks on # 8 tee boxes. The tees are being moved up on #3 & #6 for the dogfights. The tee boxes will take time to recover. Bob Thomas suggested to Lance to move the tees up on #4. The shotgun starts on Tuesdays and Thursdays have worked well. We are now having four hour rounds. We will look at having Shotgun starts for Saturday dogfights, too. We have scheduled a nine hole Night Golf Tournament for Friday, March 5.
6. Old Business: Johnny Molony addressed the three proposals made at the last meeting.



- A. Continuous Putting
- B. Inside the Leather (Gimmies)
- C. Penalty for slow Play

These proposals have been posted for two weeks in the Club House that we will vote on tonight. We have enough members present tonight to vote. We will vote on each proposal separately.

- A. A motion was made by Doug Snyder for mandatory Continuous Putting. Motion second by Burt Wronsky. DISCUSSION: Harvey Foulkes asked for clarification. If my ball is far from the hole on the green, do I putt all the way out once I start putting? Burt Wronsky said that continuous putting may be a problem if your ball is in someone's line and they object to you standing in their line. Burt suggested you would then mark your ball. James Gregory suggested that we do "ready putting." The motion for continuous putting was voted on and carried unanimously.
- B. A motion was made by Keith Sizemore for Inside the Leather, Gimmies. Motion second by Bob Thomas. DISCUSSION: Doug Snyder said that a lot of guys are playing gimmies already. If you don't want to give gimmies inside the leather, we can give gimmies inside the grip. Harvey Foulkes thinks gimmies are okay for match play, but not for stroke play. James Gregory said that we shouldn't change the rules just because other people are playing gimmies. Gimmies may reflect an incorrect handicap. The motion for Gimmies, inside the leather was voted on and defeated.
- C. A motion was made by Joel Peecook for Penalty for Slow Play. Motion was second by Keith Sizemore. DISCUSSION: Joel Peecook said that the 4-some should be penalized by one stroke each if they finish more than 20 minutes to the 4-some in front of them. Ron Phillips said you can't penalize everyone in the 4-some if you play fast and they play slow. Johnny Molony asked Lance to tell the rangers to speed us up. Ed Griffin said that we need to determine who is slow. Burt Wronsky commented on playing golf and his 4-some had to wait on the 4-some ahead of them on every hole. The ranger is not saying anything to the 4-some for slow play. Burt said he had a five hour round of golf. Bob Thomas feels that you should be given a warning the first time and then the second time, you should be told to pick up your ball and go to the next hole. Lance commented that the shotgun starts have helped speed things up. We are now having four hour rounds of golf. Several members asked Lance to ask the Rangers to range. James Gregory commented that the dogfights go faster when there's no league matches on Saturday. Doug Snyder mentioned that no league matches are scheduled for Saturdays. On occasion, a guy might make up a match that he missed. The motion for penalty for slow play was voted on and defeated unanimously.

7. New Business: Open Discussion from the floor. Doug Snyder asked if we can sell mulligans at tournaments to make money for CCGA. Burt Wronsky, as tournament director, we will sell mulligans to make money for CCGA for appropriate tournaments. Johnny Molony announced that we have 77 members of the CCGA as of Feb. 1. Please ask other golf members to join our association.
8. General Discussion: Burt Wronsky asked whether the tree stumps are coming up? Lance said that they are. Lance said that thinning of the trees helps the remaining trees grow, also it allows sunlight to get to the needed areas. It also helps us find our ball easier if we are in the trees. Mike Cornforth reminded us of a golf outing planned for Wednesday, Feb. 3 at Paw Paw Country Club in Bamberg. We have plenty of vacancies if anyone would like to join us. The cost will be \$15. This includes cart fee & green fees. We will leave from the club house @ 0830. Tee times begin @ 1000. Joel Peacock asked Lance how long should a round of golf take when it is cart path only. Lance said that the club will be more lenient on these days, about 4 hours and 20 minutes. Lance reminded everyone about the Master's policy. If you want to play that week, especially on Thurs., Fri. and Sat, you should make tee times at least 2 weeks in advance. Tee times cost \$425/foursome last year, not sure about this year. If you make a tee time you are required to hold tee times with a charge card. On the day that you play, you will only be charged for cart fees. This eliminates from making tee times and not using them. The club makes a lot of money from the outside during this week. Green and cart fees for your guest during this week is \$60. Don't forget to make your tee times early. River Chase and Jones Creek are already booked up for Master's week. Doug Snyder announced that the Senior Men's League starts Tues., Feb. 9. The senior league will :
1. Adopt all the dogfight rules.
  2. Players will be sighted for slow play.
  3. Players will take extra clubs with them when cart path only.
  4. Players will hit their ball before helping others find their ball.
  5. We will have 23 matches at Cedar Creek.

APRIL 5, 1999

1. The meeting was called to order on Monday, April 5, 1999 @ 1840 by James Gregory.
2. James welcomed all guests; 9 members present. ( see attached roster)
3. The minutes from the March meeting were read by Kathy Cornforth. A motion to accept the minutes was made by Burt Wronsky and second by James Gregory.

4. Treasurer's Report: Keith Sizemore

Burt asked what are we planning to do with our money in the Treasure? Burt suggested that we put some of the money back into the club and the club owners match that amount. - D. The staff have been putting in alot of time getting the course in good shape .
- E. Most of the tee times during Master's Week are booked up. A couple of tee times are available.

6. Old Business/ General Discussion:

Dogfight Discussion: Doug Snyder concerned about taking 5 hours to play in the dogfight Saturday. The starter worked in two groups in front of him. Harvey Foulkes said that he believes the groups in between the dogfight maybe taking up the CTP markers. Scott said he would talkto Lance about the starters and rangers. Doug Snyder talked about the time for weekly dogfights. If we start our weekly dogfight at 0800 instead of 0900, the crew doesn't have time to cut the grass when we have a shotgun start. Doug also said that the dogfights on weekdays and



Saturdays support the course. He doesn't understand why they work groups into the dogfight. The weekday dogfights had 47 & 54 players last week. MEMBERS CAN BRING ONE GUEST.** We will post the motion in the pro-shop and vote on it next month.

7. New Business: The Bylaws were reviewed by Kathy Cornforth to see who would take over as president. Our Vice-President, James Gregory will take over as our President.  
The Home Owner's Tournament will be planned by the Cedar Creek Golf Club. A new dogfight payout sheet was done by Dave Isaminger for the weekday dogfight to include more players. The sheet was reviewed. James Gregory made a motion to accept the new sheet and Burt Wronsky second the motion.
8. A motion to adjourn the meeting was made by James Gregory and second by Keith Sizemore.

CCGA Board Meeting  
May 3, 1999

1. The meeting was called to order by our President, James Gregory @ 1835 on Mon. May 3, 1999.
2. James welcomed all guests; 25 members were present. (see attached roster).
3. The minutes from the April meeting were read by our secretary, Kathy Cornforth. A motion to accept the minutes was made by Burt Wronsky and 2nd by Keith Sizemore.
4. Treasurer's Report: Keith Sizemore  
Our Beginning Balance: \$1851.25  
Total Deposits: \$338.00---Money raised from the Kathleen Messeura Tournament & 1 CCGA Cap sold.  
Total Expenses: \$330.00---Money donated to the American Cancer Society.  
Our Ending Balance: \$1859.25

A motion to accept the treasurer's report was made by Burt Wronsky and 2nd by Doug McLain. Wayne Jones commented on the amount in our treasurer and asked what is the limit for non-profit organizations before we get in trouble? We need to come up with ideas on how to spend some of our money.

5. Staff Report: Mike Hoffstetter

\*You may see some new faces around the club, grounds crew, kitchen, and proshop. Wayne Jones will be helping out in the proshop.

\*The course is in great shape. Randy and his crew are doing a great job.

\*Hoffy commented on the motion that we will be voting on tonight about "Dogfight Participation." Hoffy asked us to keep in mind that we are trying to promote golf at Cedar Creek.

\*Aeration of the greens will take place June 7th. The reason for us delaying the aeration is the heat killing the rye and the bermuda not jumping. Hoffy commented on increase play on dogfight days due to spring fever and everyone wanting to play golf. Some regular players that are not members play on Tues. & Thurs. because of reduced rates; \$26 instead of \$31.

\*There will be a Jr. Clinic on July 19-22.  
\*White Pond Road has been paved; the speed limit is 40 mph.  
\*The speed limit on Club Drive is 30 mph.  
\*Jack Stillwaggon asked Lance what are the cart fees going to next year? Lance said that he didn't know, the owners haven't given him this information. A lot of discussion on "Increase in Fees" (off the record). James Gregory is going to write a letter to the owners about the golf and cart fees. All members are welcomed to sign the letter.
