

CCGA BOARD MEETING

1/8/2001

The meeting was called to order on Monday, January 8th at 6:30p.m. Don Lemon, President, presiding who welcomed everyone in attendance. A total of 19 members and guests were in attendance.

Secretary's Report

John Andrews read the minutes from the December Annual Meeting. The meeting minutes were amended to clarify that there was not going to be a \$1 surcharge on dogfights as originally proposed. Following this amendment the minutes were approved as read.

Treasurers Report

Paul Peccoraro our new Treasurer reported that he had just received a financial statement from outgoing Treasurer Keith Sizemore which reflected that we have a balance of ~~\$2,192.92~~ ^{\$2,112.92} as of 1/01/01. The Treasurer's report was approved as read.

Staff Report

Lance Bailey gave the staff report. The cold weather during the month of December played havoc with the number of rounds played during the month. Only about half as many rounds were played as had been budgeted for the month. A total of 1,050 rounds were played versus about 1,800 last year during December.

Lance noted that many area courses had raised their rates. Cedar Creek is not raising rates for members for 2001. Weekend rates for non-members will go up \$5.00 however.

While the club will sell the new Callaway driver that has been ruled illegal by the USGA, it will not be legal to use this club during any tournaments here.

March 17th will be the Club's 10th anniversary and it will be

celebrated by holding a 10 year Anniversary golf tournament. This tournament will be a four person scramble with teams picked by the computer. In addition, current plans call for a Member-Guest Tournament on May 18, 19 and 20th. The Club Championship will be held on August 25 and 26.

Randy Richardson, our Club Greenskeeper , reports that despite the cold weather, the course should come thru the winter in good shape.

Burt Wronsky noted that many of the rakes in the sandtraps need to be replaced and some are missing. Also, the machine raking the traps continues to leave furrows in the sand which indicates something must be wrong with the equipment or it is being operated improperly.

Tournament Director's Report

Pat Sullivan our new incoming Tournament Director presented a handout which detailed dates for our 2001 tournaments. These dates and tournaments will be posted on the bulletin board and placed in an upcoming issue of the Sandbagger.

In addition, Pat explained a new idea of a Friday evening nine hole scramble tournament beginning on April 20th. Information on this tournament will also be given in the Sandbagger.

Finally, a new idea for 2001 of Winner Points was given and explained by Pat.

Old Business

There was no report at this time from the Handicap Committee. Marty Katz gave a report on software preparation for the Dogfight. \$586.00 was the cost for the computer equipment purchased by Marty. In addition, we will need to buy a stand which will cost approximately \$125. Marty did a great job of purchasing this equipment at a very reasonable cost and received a vote of thanks from the group. Marty explained how the new process would work and how user friendly it should be. He

indicated that we should be using the computer and software by mid-January. Pretty much all that remains to be done is to input current history into the computer.

Jerry Sullivan volunteered to work with Marty to designate an operator who will be trained on how to use the computer and the software system. Also, he will get some volunteers to help orient players for the next two or three weeks regarding how to use the computer to enter the dogfight. We will use both the new and old system for a short time to make sure everything is operating properly before totally relying on the computerized system.

New Business

Lance talked about ideas for improving participation in tournaments. The Winner Points idea was discussed further as the main way to get more people to participate. Points would be awarded based upon both winning and participation. The top 10 places would be paid at the end of the year. Discussions were held regarding where the prize money would come from. Ideas included, the Cedar Creek Golf Club, The Cedar Creek Golf Association, sponsors and finally charging players a nominal fee each tournament—something like a dollar. Don Lemon asked Lance to begin with looking for sponsors.

Burt noted that we need to take care of getting the Memorial Chair engraving completed and also update the plaque for CCGA Presidents. John Andrews also noted that the Club should provide a plaque denoting members who get a hole in one at the course and also start a plaque for the Member-Guest Tournament. Lance will review these items.

Don Lemon and John Andrews talked about the need for more participation from members to help keep the course looking good. Lance noted that the adopt a hole program wasn't working particularly well right now. Ideas to rejuvenate the program were discussed. Lance is going to follow up on some of these ideas and announce something soon for members to participate in along the lines of adopt a hole.

Wayne Jones has completed the black tee handicaps and they are now available. Wayne needs 200 cards of players having handicaps between 0-12 and 18 and above to get the white tees also rehandicapped by hole.

After considerable discussion, Jack Bahen made the motion that we adopt a club rule that we play the golf ball down in all club tournaments and during dogfights unless the pro shop provides for lift, clean and place rules for that particular day. Doug Snyder seconded the motion. Much discussion followed. A vote of 13-4 resulted in the motion carrying and it was decided to implement the rule immediately.

Following a motion to adjourn and a second the meeting ended. The next meeting will be held on Monday, February 5, 2001.

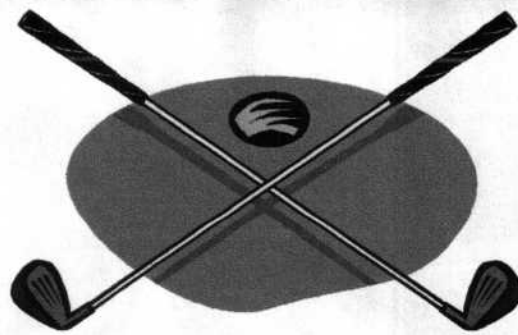

2001 Cedar Creek Golf Club Money List

The 2001 Cedar Creek Golf Club Money List Program will award points for play in events that are sponsored by Cedar Creek Golf Club and the Cedar Creek Golf Association. The season will end with the final tournament being played at the Annual Meeting of the Cedar Creek Golf Association in December of 2001.

Points will be awarded for playing in these events as follows:

Playing in the event	1 Point
First Place	5 Points
Second Place	4 Points
Third Place	3 Points
Fourth Place	2 Points
Fifth Place	1 Points

Players will receive double points for their finishing position in the Club Championship and Member-Guest Tournaments.

(Example: Each first place player in each flight will receive 5 points. Each second place player in each flight will receive 4 points. etc. There could be multiple players winning points, but the final determination will be the cumulative total at the end of the year.

Running total will be published each month. Cumulative totals for the year will be determined after the final event.

Prizes will be paid to the top 10 players (and ties) based on the final totals.

Money will be collected out of the entry fee for each event. The money will be deducted at the rate of one dollar per player per event. All money collected will be placed in the pool for the final prizes.

Additional monies could be added by the Cedar Creek Golf Association, Cedar Creek Golf Club, and/or a sponsor. This would make the year end prizes more substantial.

PROPOSAL

CCGA BOARD MEETING

February 5, 2001

The meeting was called to order on Monday, February 5, 2001 at 6:30p.m. Don Lemon, President welcomed everyone in attendance. 19 members and guests were present.

Secretary's Report

John Andrews read the minutes from the January meeting. The minutes were approved as read.

Treasurer's Report

Paul Pecoraro reported that as of January 24, 2001 there was a balance of \$1,491.74 and that he had a deposit of \$203.00 that would be added to that balance. Prior to the meeting, Paul had received membership dues from 38 members. The Treasurer's Report was approved as read.

Tournament Director's Report

Pat Sullivan reported that the Association will be holding a Par 3 tournament on February 17. A 9:00a.m. shotgun start will kick things off. Tees will range between 50 and 180 yards. Prizes will be given for low net and gross scores. Mulligans will be sold for \$5.00 a piece.

Pat thanked the association on behalf of Jerry and herself for the flowers that were sent by the Association to honor the life of Jason Sullivan.

Staff Report

Wayne Jones gave the Staff Report and began by encouraging all of us to work towards increasing participation in the upcoming tournaments beginning with the Par 3. The weekend of March 16-18 will mark the 10th Anniversary of Cedar Creek Golf Club. The event will be celebrated with a golf tournament, reduced prices, long drive contest, etc. Old members are being invited back to play in the tournament and the participation will be limited to the first 100 players. Foursomes will be picked by the computer.

Wayne further explained that during the next several weeks cutting of trees and limbs will occur on holes 14 and 15. During that time, the rules state that if your ball comes to rest in the brush piles that may be found on these holes, you are allowed relief for stance and swing plus one club length no closer the hole. Signs will be placed on the tee of each hole explaining this rule.

Jack Stillwaggon asked if the grounds crew could blow the leaves around several of the greens.

Jerry Sullivan mentioned that ropes need to be fixed on several holes to avoid the carts running in places they should not be going.

Ed Griffin mentioned that the sand box on hole 10 needs to be replenished. Wayne explained that the course is considering getting more sand bottles and making them available around the course.

Doug Snyder questioned why we are doubling up on the tees during some dogfight days and not others. He feels the dogfight goes much faster when we do not have to double up. Wayne was not sure why this was happening. Usually, he mentioned, we have foursomes double up because of maintenance work going on at the time.

Don Lemon asked if we have an update regarding getting sponsors for the Member Points idea that was presented at the last meeting. *Wayne reported that as requested by the membership at the January meeting, Lance Bailey requested that Cedar Creek Properties Inc. be a sponsor of Member Points this year and make a \$250 donation to this event. It appears that Lance was told no that Cedar Creek Properties would not be a sponsor or provide us any support!* There was general unhappiness with the members regarding this lack of support by CCPI since this was the first time in recent memory anyone could recall having asked them for any help. Wayne did indicate that he feels that there could be others who will sponsor the Member Points concept.

Burt Wronsky asked about permanent sponsor signs on holes around the course. Wayne stated based on what has been said in the past that the owners of the course would not be favorable to such an idea.

Finally, a discussion ensued about moving the tees around on tee boxes in order to not wear out the grass on the tees.

Old Business

Marty Katz gave us an update on how things are proceeding with using the computer for the dog fights. We have recently had a small problem which has since been corrected. Otherwise, the computer is fully operational and we should be able to fully utilize it now going forward.

Pat Sullivan asked about how a new person gets into the computer when playing in an initial dog fight. Marty explained that there are written instructions now available beside the computer detailing how one goes about initially signing up for the first time.

Don Lemon brought up that at the January meeting we voted on playing the ball down and have since realized that three or four people who voted were ineligible to vote since they had not yet paid their annual dues. Therefore, he suggested that we rediscuss this issue.

Otis Beard moved and Mike Lehrhaupt seconded that we go back to the old rules and move the ball one clubhead in the fairway. A long discussion ensued with many good points raised by those who want to roll the ball and those who want to play it down. Following the discussion there was a 14-3 vote to not be able to move the ball one clubhead. Following this vote, Doug Snyder moved that the roped off area on number 2 fairway be treated as a lift, clean and place fairway. Paul Pecoraro seconded the motion. After discussion the motion was defeated 13 to 4. Therefore, after all these votes and discussion, we will continue to play the ball down in the fairway unless the Pro Shop declares otherwise for that day only.

New Business

Pat Sullivan mentioned that we need information in the Pro Shop for new people that explains what kind of activities are available at the Club such as dog fights, leagues, etc. Also, we need to have information about our Association available. John Andrews, Pat and Wayne Jones agreed to work on this.

The Handicap Committee of Jack Stillwaggon, Doug Snyder and Andy Hendrix held their first meeting and have made their first recommendation. The first recommendation relates to the issue of people possibly failing to turn in their scores after playing a round. If this is noted by another player who wishes to report this to the handicap committee, it will be further investigated by the Committee. If the Committee determines that a player has willfully failed to report their score and there are no extenuating circumstances that would have prevented the player from doing so, a 72 will be posted on the computer for that player's score.

A motion was made and seconded and it was voted that the meeting be adjourned.

CCGA BOARD MEETING

03/05/01

The meeting was called to order on Monday, March 5th at 6:30 p.m. Don Lemon, President, welcomed everyone in attendance. 15 members and guests were in attendance.

Secretary's Report

John Andrews read the minutes from the February meeting. The minutes were approved as read.

Treasurer's Report

Paul Pecoraro, Treasurer, reported that we had a balance of \$2,147.42 beginning January 8, 2001. After various deposits and paying for the computer, software and supplies we had a balance of \$1731.51 on March 4th. The Treasurer's report was also approved as read.

Tournament Director's Report

Pat Sullivan, our Tournament Director, reported that the participation in the most recent Par 3 Tournament was very good and exceeded 60 participants. Mulligans were quite popular and raised in excess of \$300 dollars. This year Pat gave cookies for every mulligan purchased which was quite popular. She has decided to continue doing something like this for each tournament. Pat reported that the next tournament is a Pro Shop tournament to be held on March 17. She urged us to participate and get others to play. 24 spots remained as of March 5th of the 100 maximum participants allowable in this particular competition.

Handicap Committee Report

Jack Stillwaggon reported that the committee will be ordering some USGA publications in order to assist them in their duties. As of March 5, no one has reported anyone failing to turn in scores after playing a round. This is hopefully a good sign that players are taking seriously their duty to report their scores.

Marty Katz reported a few minor changes he has made to the computer software program.. Jerry Sullivan stated that we need more people

trained as administrators of the program besides himself and Otis Beard. A discussion took place regarding this. As a result, Don Lemon volunteered to replace Jerry or Otis on Tuesdays if they are unavailable, Jack Stillwaggon will do Saturdays, Andy Hendrix is available on Tuesday or Thursday along with Burt Wronsky. Jerry or Otis will let one of these people know if neither plans on being there on a Tuesday or Thursday. Wayne Jones indicated that the person running the Pro Shop should put the computer administrator in the first group on the first tee. Also, Jerry indicated that it would be helpful to have JD Wiggins move the computer into the grill on Thursdays. Jack Stillwaggon also agreed to call one of the volunteers if he is not going to be there on Saturday.

Next, a discussion took place about people playing in the dogfight and not putting their name in the computer and/or book. Pat Sullivan strongly suggested that we post a sign in the Pro Shop stating that you must put your name in the computer in order to be qualified and pay your fee before the dog fight starts.

Staff Report

Wayne Jones reported that the limb trimming and tree cutting is about over on all holes. Cleanup should be complete in the next few days. Mowing is getting back to a regular basis. Aerification is currently being applied to the 4th green. The course should be looking better soon with the advent of warmer weather.

The March tournament is looking good. Pretty sure we'll have a full tournament of 100 players. Should be a fun weekend with the special events and the return of several former members and staff.

It has been noted that some people have been starting play from someplace other than the clubhouse. Perhaps this has been residents starting from their house. This is not allowed and should be discontinued immediately.

The driving range has been busier. Several local ranges have closed giving the course more business. All new range balls will be coming in during the month of March.

Adopt a hole began today, March 5th. Still need more participants. Perks will be given to those who volunteer to help repay them for their efforts. Finally, new rakes have been ordered for several traps.

Doug McLane mentioned that the 15th hole has a sand trap that is badly in need of maintenance.

FORBES TRAVEL has donated \$250 to become a sponsor of our new Member Points program. Thanks go to Barry Cooper for helping us out in getting this program off the ground.

New Business

Considerable discussion took place around the subject of mulligan money that is raised during tournaments and how it should be disbursed. A motion was made by Jack Stillwaggon that 50% of the mulligan money go into the prize money and the rest be spent as follows: 25% will go to fund the points program(if additional sponsors are not found) up to a maximum of \$525.00. All remaining monies go into the treasury. This motion was seconded . The motion was approved by a vote of 8 to 5. Paul and Pat will work out the payouts for the tournaments as result.

A question arose about what to do with money that has been left unclaimed in past dogfights after six months. The Secretary was asked to explore past minutes to see if we had voted how to deal with this. (Note—I could not find in the past two years minutes any discussion dealing with how this money was to be handled.)

The last piece of business discussed at the meeting was how could we volunteer to work as marshals at the fall LPGA tournament at Mount Vintage Country Club. Ed Griffin brought this subject up and suggested we consider doing this as a group from members at Cedar Creek assuming there was enough interest. Wayne Jones said that he had spoken to the staff at Mount Vintage about volunteers and they do not have this figured out yet , but indicated they would get back to him with details in the near future.

After a motion and a second, the meeting was adjourned. Our next meeting will be held on Monday, April 2, 2001.

Secretary's Report

July 2, 2001

The meeting was called to order at 6:35pm. Joel Peecook presided and Paul Pecoraro took the minutes. 16 members were present. Don Lemon, President and John Andrews, Secretary were unable to attend.

SECRETARY'S REPORT- Jack Stillwaggon read the minutes from the June meeting. The minutes were accepted as read.

TREASURER'S REPORT- Paul Pecoraro reported that as of 7/1/01 we had a balance of \$2237.04 in our account. \$422.00 of the balance has been reserved for the Forbes Travel Awards. Future CCGA mulligan funds of \$103.00 and \$250.00 due from Forbes will complete the targeted funding goal of \$775.00. Total membership is now 72. The report was approved as read.

TOURNAMENT DIRECTOR'S REPORT- Mike Cornforth announced that the Red, White, and Blue tournament would utilize the Black tees as the starting point for those entrants that desired. The Beat The Pro Tournament is scheduled for 7/28. Mike filled in for Pat Sullivan who was on vacation.

PRO SHOP REPORT- Mike Hoffstatter reported that the sod project on the seventh green was finished and the practice putting green should recover in approximately two months. Mike reviewed the upcoming tournament schedule with special emphasis on the Club Championship on 8/25 and 8/26. Ron Phillips requested that drainage be investigated for the low area on the left side of the #1 fairway. Mike said that the low area was natural and no alteration was planned. Doug McLane requested a rules clarification regarding relief from the 150 yard posts and other posts along the cart paths. Mike explained that Cedar Creek Golf Course has declared the posts to be an integral part of the course and therefore treated as immovable obstructions. The result of this local rule is to eliminate the additional line of flight relief provided for by USGA rule #24-1(Movable Obstruction). An animated discussion ensued that resulted in a motion by George Ferko, seconded by Doug Snyder, to recommend that the Golf Course Management research an inexpensive alternative that would be readily removable. The motion passed by a 10 to 5 vote. Mike agreed to look into the issue, but said that he doubted that any acceptable solution existed costing less than one thousand dollars. Mr. Ferko said he could get it done for much less if the course would give him that amount. Wayne Jones reminded all attendees that the CCGA members did not have the authority to direct the Golf Course Management on issues involving course management. Following some simultaneous yelling by virtually all present, Joel Peecook regained control of the meeting by declaring an end to the discussion and asking if there were any other issues for the Pro Shop. Jack Stillwaggon recommended that metal spikes be banned. Mike said that the current policy benefited the clubhouse carpeting more than the condition of the greens, but he would consider the issue and let us know. Bob Fruin, guest, suggested that more advance information regarding payouts and rules for tournaments be published. He specifically mentioned the confusion about the handicap percentage and gross and net prizes on the flyer publicizing the Modified Stableford

tournament. Joel responded that this information would be passed on to the Tournament Director, but Mr Fruin's other issues should be addressed directly to Golf Course Management. There were no other issues for the Pro Shop, but before we moved on to other business Paul Pecoraro voiced his disappointment that CCGA member opinions were not being adequately considered and this was straining the relationship between the CCGA and Golf Course Management. He cited the absence of logic in creating a local rule making the 150yd markers an integral part of the course as an example. Since this rule is not published in any manner, only those people most likely to return the post to its original position, those attending this meeting, are aware of the rule. Most Cedar Creek Members and the general public have no idea that when playing Cedar Creek you should be aware that the club has declared "exception c under note 1 of USGA Rule 24" to be in effect for the 150yd. markers. The result is the members are penalized and the golf course still has the same risk of suffering damage. It is difficult to find the advantaged constituency, so why make the rule.

OLD BUSINESS- None

HANDICAP COMMITTEE- Nothing to report.

NEW BUSINESS- Doug McLane made a motion, seconded by Andy Hendrix, and unanimously approved, to award all CCGA members who make a hole-in-one a plaque commemorating the event. Ed Griffin made a motion that a plaque also be purchased for the club room listing all future aces. This motion was seconded by Ron Phillips and unanimously approved, with a target price of \$50. Ed Griffin agreed to research the cost and availability of both awards. Burt Wronsky initiated a discussion suggesting an additional payment from non CCGA members that play in the dogfight. No motion was offered and the general consensus was that no change was necessary. Jack Stillwaggon made a motion, seconded by Burt Wronsky and unanimously approved, to award Marty Katz two \$75. gift certificates to local restaurants, as a thank-you for his considerable effort obtaining and programming the computer used for recording the dogfights. Paul Pecoraro volunteered to purchase the gift certificates and present them to Marty at an appropriate time.

Following a motion and a second, the meeting was adjourned. The next meeting will be held on August 6, 2001 @ 6:30pm.

08/06/01

The meeting was called to order on Monday, August 6th at 6:30p.m. Don Lemon, President, welcomed everyone in attendance. 17 members and guests were in attendance.

Secretary's Report

John Andrews read the minutes from the July meeting. The minutes were approved as read.

Treasurer's Report

In the absence of Paul Pecoraro, Treasurer, John Andrews read Paul's report. As of July 25, 2001, we have a balance of \$2284.03. Pending our receipt of funds from Forbes Travel, we have essentially funded the \$750.00 for our Forbes Travel Member Points awards. In addition, it was reported that we now have 88 dues paying members for the year 2001. The report was approved as read.

Tournament Director's Report

Pat Sullivan, Tournament Director, reported that participation for the August 11 scramble tournament was looking rather low. Various reasons have contributed to this. Pat urged participants in the meeting to play and to seek others to also participate.

The meeting was called to order on Monday, September 10th at 6:30 p.m.. Joel Peacock, President, welcomed everyone in attendance. 13 members and guests were in attendance.

Secretary's Report

John Andrews read the minutes from the August meeting. The minutes were approved as read. There was a brief clarification made regarding eligibility for the hole in one awards.

Treasurer's Report

Paul Pecoraro, Treasurer, presented his report. We had a balance of \$2,310.77 as of 9/07/01. The account balance includes \$500 that will go towards the Forbes Travel Awards. As of the September meeting we have 88 dues paying members.

Pro Shop Report

Mike Hoffstetter presented the report. Aerification of the greens has just been completed during the first week of September using small tines. Overseeding will begin during the last week of September through the first part of October. Once again, Cedar Creek is overseeding with rye on tees, greens, rough and fairways. No large corporate outings are planned during September but several will occur during October.

Mike distributed a copy of that section of the CCGA constitution that describes the purpose of the organization. Our purpose is "This organization has been formed to promote fellowship among members of Cedar Creek Golf Club and to foster a desire for advancement and improvement of their golf games."
