### **Secretary's Report**

The minutes from the 4/14/03 meeting were read and accepted.

### **Treasurer's Report**

The amount in the treasury is \$2522.60. The only expenditure this past month was \$800 for the flag.

### **Tournament Director Report**

The tournament held on 4/14 had 84 players with 33 winners. The year to date total is 328 players and 124 winners, averaging 82 players and 31 winners per tournament. 54 members have signed up for the tournament next month.

### **Pro Shop Report**

The dog fight on Saturdays will start at 9:00 except when there is an outside tournament. Ropes and posts on golf course will be removed to help beautify the course and will be installed on #2 and par 3s only. The dog fights on Tuesday and Thursdays are getting busy and the staff is trying to implement things to make everything run as smoothly as possible. #11 will be fixed and cleaned up - play as ground repair until further notice. Groups playing should determine wash out relief within reason.

### **Rules Report**

Ron Phillips discussed rule #16, the putting green. The line of the putt cannot be touched except to remove debris, sand, etc. As to ball marks, they must be marked before you pick up and cannot test putting surface with ball. As for a ball hanging on the edge of the cup, you can walk up to ball in reasonable time then you get 10 seconds to complete the putt.

### **Old Business**

The flag project is on hold until it can be installed upon delivery. It is still to be decided about the plaque and how we want to dedicate it. Doug McLane made a motion for the flag committee, Wayne, Doug, and Pat, to decide how the plaque should read. Ed Griffin seconded it. The vote and motion carried.

The June meeting was called to order on Monday, June 9, 2003 at 6:30 pm. Paul Pecoraro , president, presided . Sixteen members were in attendance.

### **Treasurer's Report**

The funds to date are as follows: Checking \$2756.05 and \$10.00 cash on hand, totaling \$2766.05. The treasurer's report was accepted as given.

### **Tournament Director's Report**

The fourth club tournament attracted 79 players , 29 of which were winners. The year to date totals are: 407 players, and 159 winners. The next tournament is 6/14, a team event, with teams being decided 6/13.

### **Pro Shop Report**

The club is entering a transition period; waiting for the Bermuda to grow . Organic fertilizer was applied May 27. Beginning the week of 6/10, number 4 green will be converted to tif eagle grass and the two putt rule will be in effect for two weeks. Note: will use cup size sod implants.

### **Rules Report**

**Tournament Director's Report**

**Pro Shop Report**

**New Business**

Effective October 13, 2003, the Cedar Creek Golf Association, with the support of the Cedar Creek Golf Club will, on a trial basis, implement a handicap audit system (HAS). This system, which applies to all club members, will, we think, add needed structure and credibility to the existing handicap reporting system. In essence, on a random basis, 10-12 players will be audited periodically to determine if they are;

1. Entering their scores in the handicap computer.
2. Complying with the Equitable Scoring System in scoring their rounds.

What must you do? It's quite simple Using the Equitable Scoring System enter ALL of your 18 hole scores at the completion of your round. That's it....nothing more. Failure to do this could result in a par 72 score being entered for you.

Obviously some compromises are in order. For example, when playing in an event or practice round where you will be picking up your ball after a certain number of strokes (dogfight) or you are playing more than one (1) ball you must, using the Equitable Scoring System, anticipate a score for each hole in determining a score for the 18 hole round.

**THE KEY IS FOR EVERY PLAYER TO ENTER A CREDIBLE SCORE FOR EVERY 18 HOLE ROUND PLAYED.**

This issue will be discussed further during the November 2, 2003, Cedar Creek Golf Association meeting.

**Old Business**


