CEDAR CREEK GOLF ASSOCIATION MONTHLY MEETING

January 17, 2006

President Dan Mulvey called the meeting to order at 6:30 pm and welcomed everyone. Dan reminded the audience that there is a sign in sheet and a sheet to indicate e-mail addresses and changes.

<u>1. PRESIDENT'S REMARKS</u>: Dan began the meeting by reading a list of chapters of a book on humorous golf stories being written by a friend. Dan thanked the 2005 Board and Committees, including the Dogfight Committee, for their service. Dan then introduced the 2006 Board and had each member of the audience introduce themselves. Dan also reminded the members to be recognized by the chair when wanting to speak on an issue, to stand up and identify themselves and not to interrupt other members when they have the floor.

2. MINUTES OF PRIOR MEETING: Dan announced that since the minutes of prior meetings have been posted in the Members' Lounge and sent out by e-mail they would not be read by the Secretary. He asked if there were any corrections or additions to the December Minutes. There being none, he declared the Minutes approved as posted.

<u>3. TREASURER'S REPORT</u>: Andrew Wilson reported that as of January 17, the balance in the treasury was \$1,663.75. Andrew explained what the expenses and income were up to January 17th. The report was accepted as given

<u>4. a. PRO SHOP REPORT</u>: Mike Hoffstatter thanked CCGA and everyone for their thoughts and prayers in the sudden passing of his father.

<u>4.b.</u> Mike announced that on February 4 the "Beat The Boss Tournament" will take place at 1:00 pm. Sign up is in the Pro Shop. Mike also announced that there will be a CSRA ladies' tournament held Monday, January 23.

4.c. Mike reported that tree removal will continue in areas for turf and sunlight improvement. He explained the process of tree removal. Mike indicated that the greens were being cut, top dressing the greens is being done on the outside of the greens (mostly were people walk) and explained the "clean-up" laps around the greens. Fairways are being mowed as needed. Several holes have not been reseeded. Nine holes will be closed at a time in a few weeks when sprayed for weed control. Drainage problems are being addressed.

<u>4.d.</u> In response to concerned members requesting explanations regarding the tree removal taking place on the course, Art Kennedy, representing the ownership, further explained the necessity of the removal in order to improve course playability. Both Art and Mike referred to an article written in the Carolinas Golf Association Magazine on how tree removal is important to golf course restoration. Art explained the maintenance

plans taking place on each hole involved and stump removal. Art stated that the trees taken down have not been sold. He also stated that the money made on the course during the last two years has been put back into the course and a percentage of the fees that Cedar Creek Development receives from the builders are also put into the course.

<u>4.e.</u> Art answered questions from the audience. Dan thanked Art for enhancing communications between the members and the owners.

5. SAFETY COMMITTEE: John Turner stated that the On Course Medical Emergency Committee, put in place by the 2005 Board, has presented a written report. This report was presented to Hank Thurmond last week. After Hank has had a chance to review the report the Committee will then present its findings and recommendations to the members.

<u>6. MEMBERSHIP COMMITTEE:</u> Dan announced that a new member packet is available in the Pro Shop with a welcome letter, etc.

7. TOURNAMENT COMMITTEE: Greg Pasco reported that 67 players participated in the January 14th 4 Club Tournament. This is a 6.5% increase over 2005. The next tournament will be held February 18 at 10:30 and will be "Best Ball, Alternate Shot". Greg announced that the sign up sheet is in the Pro Shop and the tournaments may be prepaid in order to speed up check in. In response to a motion made in April, 2005, breakfast will be served between 8 and 10 am instead of lunch for this tournament.

8. OLD BUSINESS:

<u>1. Memorial Area</u>: Art Kennedy reported that the plants are in and the Memorial Stone ordered and hopefully will be completed within the next month.

2. Tournament Survey: Greg Pasco handed out copies of the survey results and comments. He thanked Bill Robinson and Phil Stack for undertaking this project. The survey results have been discussed with the club management. Greg discussed many of the comments on the survey and the Committee is putting some ideas in place (e.g. the April Tournament will be held at 1:00 pm, will also be flighted, include gross and net prizes and possibly a dinner with spouses or guests after the tournament.) The Committee expects to survey members later in the year. Greg suggested deferring additional comments and questions until next month when the members have had a chance to read and digest the survey.

9.a NEW BUSINESS: Dan announced the following Goals for 2006:

1. To enhance association fellowship and the desire to improve individual golf games through the expansion of various types of quality CCGA events. (e.g. Match Play, etc.)

2. Continue to foster a level playing field for all CCGA golfers by adhering to



USGA Rules as well as supporting a pro-active Handicap Committee (e.g. Rule Reviews)

3. Increase participation in CCGA meetings, events and programs. (e.g. Emergency response efforts, guest speakers)

4. Support worthy causes of which we all can be proud. (e.g. Rally For A cure, 1 ocal H.S. Golf Teams)

5. Have fun and enjoy!

9.b. Dan introduced the following Objectives to support the Goals:

1. Increase total Association membership by 10% by 12/30/06.

2. Increase average Association meeting attendance by 15% by 12/30/06.

3. Raise tournament participation by 10% by 12/30/06.

4. Have at least one inter-club event by 11/1/06.

5. Complete a Constitution/By-Laws review by 6/30/06.

6. Have a Memorial Garden dedication by 5/30/06.

7. Have placed at least one AED in the Golf Club by 9/30/06.

1. PRESIDENT'S REMARKS: Dan began the meeting by sharing an amusing golf story . He reminded the members to be recognized by the Chair when wanting to speak, to stand up and identify themselves and not to interrupt other members when they have the floor. Dan asked that before putting forth a complex motion, it should be submitted in writing to the Board in advance of the meeting. This will help to keep the meeting running in a timely and organized manner. Dan announced that as a result of a motion passed at the January meeting, the Dogfight Rules have been updated. <u>5. MEMORIAL COMMITTEE:</u> It was announced that the stone for the Memorial Garden has arrived and was installed and additional bricks and topsoil were added. A dedication ceremony is tentatively scheduled for April. It was asked that members provide any thoughts and/or suggestions to Committee Chairperson, Jerry Kothera.

6. SAFETY COMMITTEE: John Turner reported that Hank Thurmond has replied in a letter supporting the Committee's recommendations. However, the Committee will be addressing concerns expressed in the letter and will report next month after clarification. John also reported on the completion of a map that equates the golf course to street addresses which will enable emergency responders to have access to a golf course emergency via a street address. Copies of this map will be provided to local emergency response units and placed in the Golf Shop.

7. MEMBERSHIP COMMITTEE: Bob Armstrong has agreed to Chair this Committee. Bob is acting on the suggestion of volunteer "caddies" to help new members. Volunteers are needed and may sign up on the list at the desk in the Pro Shop.

<u>8. PROGRAM & EVENTS COMMITTEE</u>: Dan is currently acting as Chair and is in need of additional volunteers. At this time, match play and interclub play are first priorities for completion.

9. PRO SHOP REPORT: Mike Hoffstatter stated that bunker reconstruction is taking place on holes #6 and 7, trees and stumps are still being worked on and weed control has taken place over the past several weeks. The on-course restroom on #15 is not yet completed and the restroom for the front nine is awaiting EPA, etc. approval. New carts will arrive in early April and new spring items for the Golf Shop will be arriving in Mid March. Master's Week policies will be announced as we get closer to that time. Mike fielded several questions from members.

10. HANDICAP COMMITTEE: Paul Pecoraro stated that the Committee will be sending out a "first ever" annual letter soon regarding handicapping.

11. RON THE RULE MAN: Ron Phillips introduced George Montgomery who will be helping Ron with Rules. They will be looking at all the new USGA Rules changes and reporting on them periodically throughout the year. Ron acknowledged the new rule regarding using a distance finder on the golf course but added that there needs to be a local rule regarding its use. Ron will also look at the local rules that USGA states can be used at this club. It was also mentioned that artificially warming golf balls (i.e. using hand warmers) is illegal. However, the rule states a ball may be warmed BEFORE a round starts. The Unplayable Ball Rule was discussed.

12. OLD BUSINESS: Dan asked if there were any questions regarding the results of the CCGA Survey presented at the January meeting. Paul Pecoraro asked if the question on the meal purchase requirement indicated a problem. The answer was that no, the meal purchase requirement had not made a considerable difference in attendance. George Patterson asked if there was an option on receiving Golf Shop Credits, (e.g. range balls, cart fees, etc.) in addition to Golf Shop Certificates. The response was that the Board will look into options other than Golf Shop Certificates only.

13. NEW BUSINESS: There was no new business.

14. The next meeting will be Tuesday, March 21st at 6:30 pm.



5. TOURNAMENT COMMITTEE: Greg Pasco reported that the March Par 3 tournament was a success with 64 players participating. The April 29th tournament will be the Spring Stroke Play Tournament and will be flighted and separated by tees. Lunch will be served from 11:00 A.m. to 12:45 P.M. Sign up is in the Pro Shop.

<u>6. a. SAFETY COMMITTEE:</u> John Turner explained the formation of the Committee and that the Committee had made suggestions to upgrade the radio system at the club house. They also looked into placing an AED in the clubhouse and at other positions around the course. The Committee has recommended that there should be an AED in place at the clubhouse as a start. Also, a map has been completed that equates the golf course to street addresses to enable emergency responders to have access to a golf course emergency via a street address. Copies of this map will be provided to local emergency response units and the Pro Shop.

The golf course owner, Hank Thurmond, has agreed to be responsible for the system, record keeping, maintenance and AED training. Fundraising needs to take place in order to raise money to eventually cover the golf course with AED's. John explained the Good Samaritan Act and answered questions from the audience. He stated that a subcommittee for fundraising would be put in place for a start. Dan announced that there would be a Jerry Sullivan Memorial tournament to kick off the raising of money for the AED's.

<u>6.b.</u> John Turner made a motion that CCGA donate \$250 toward the purchase of an AED (Automatic External Defibrillator) for the clubhouse. The motion was seconded and carried.

Dan thanked John and his Committee for their efforts to date.

7. HANDICAP COMMITTEE: Paul Pecoraro reported that a handicap letter has been written and will be distributed to the members in the next couple of weeks. Paul also presented a short golf quiz. The winner was Greg Pasco.

8. MEMBERSHIP COMMITTEE: Bob Armstrong announced that he is looking for more volunteers to help new members to familiarize themselves with Dogfight procedures, Friday night scramble, sign ups, etc. (Dan mentioned that the Friday night scramble is not a CCGA event but is a fun tournament and will begin mid April).

9.a. PROGRAM EVENTS: Dan reported that the Inter Club Play was waiting for information from the Houndslake Pro. The Committee is looking into a day trip golf outing to a local golf course with the possibility of using a bus for transportation. Bill Steinle will be distributing a survey by the next meeting regarding interest in having a member/guest tournament or member/member tournament in 2007. Dan also asked if anyone was interested in participating in the Carolinas Golf Association which is an interclub tournament. Seven or eight members were interested but Dan didn't know if it was too late to participate this year. If so, it will be pursued for next year.

<u>9.b.</u> John Turner stated that there will be a qualifying round on June 3 for anyone interested in participating in the CCGA Match Play 2006.

10. PRO SHOP REPORT: Mike DePasquale gave an update on Mike Hoffstatter's condition and gave out Mike's home address for members to send cards (108 Mill Run, North Augusta, SC 29860). Mike D. verified that June 3 was the date set for the Match Play qualifying round.

11. OLD BUSINESS: There was no old business.

12. NEW BUSINESS: Burt Wronsky remarked that some members had commented on wanting to be able to "roll the ball" on the fairways during a Dogfight. After some discussion it was suggested that the Handicap Committee together with the Golf Club make that determination at each tournament, or period of time, depending on the condition of the course.

13. The next meeting will take place Tuesday, April 18, 2006 at 6:30 p.m.



May 16, 2006

President Dan Mulvey called the meeting to order at 6:31 pm and welcomed everyone. New member, Brad Caudle introduced himself. Dan asked the members to give him jokes, anecdotes or stories. Dan read a short story.

<u>1. MINUTES OF PRIOR MEETING</u>: Dan declared the April 18, 2006 Minutes approved as posted as there were no additions or corrections.

2. TREASURER'S REPORT: Andrew Wilson reported that the current balance in the Treasury is \$1,951.97. Andrew explained the expenses and income up to May 16. He stated that \$250 had been transferred to the AED account as approved by the members at the April meeting.

3. TOURNAMENT COMMITTEE: Greg Pasco announced that 56 members participated in the April 29 Spring Stroke Play Tournament. He reported that the average participation in the tournaments was down from last year. The next tournament will be held Saturday, May 20. The format will be a Modified Scramble which Greg explained to the members present.

4. WELFARE & SAFETY COMMITTEE: Dan announced that the "Safety Committee" is now known as the "Welfare & Safety Committee". John Turner reported that a subcommittee, consisting of himself, Pat Sullivan, Andrew Wilson, Sue Mulvey and Greg Pasco, has been formed to assist in fundraising for AEDs. A brochure will be available shortly which will explain the need and future fund raising events. There will also be a request for individual donations. <u>6.b.</u> John Turner stated that the Match Play qualifying round will take place Saturday, June 3. The Committee consists of Andrew Wilson, Bob Podewils, Paul Pecoraro and John Turner. Sign up sheets are posted, the cost is \$40 and dates for the Matches to be concluded will be posted. The purpose of a qualifying round is to seed the flights.

The event is for all levels of golfers.

7. CONSTITUTION AND BYLAWS: John Andrews spoke for the Committee consisting of Mike DiSilvestro, Chair., Bob Armstrong and John. Local Rules

Abnormal Ground Conditions / Ground Under Repair

In addition to any area of the course specifically marked as such, the following conditions will be considered Abnormal Ground Conditions. A player whose ball lies in, or whose stance or swing area is interfered by, any of these conditions may take relief without penalty, within one club length of the nearest point of relief, not nearer the hole (Rule 25-1). Penalty for breach of local rule: Match play – Loss of hole; Stroke play – 2 strokes.

- Earth/grass covered drainage ditches (french drains), i.e. those with rocks or stones beneath the grass that could cause damage to a club, including the azalea plantings to the right of the 2nd green,
 - Water diversion ditches (i) to the left of the 2nd fairway, (ii) to the left and in front of the 7th tee, and (iii) to the left of the 18th fairway,
 - The Memorial Garden area to the right of the 7th green.

0

Rules for the day will be determined and posted by the Handicap Committee and the Club Manager dependent upon the weather and course conditions.

- On any hole(s) designated by the Club Manager as 'Cart Path Only', a ball on any closely mown area through the green may be lifted without penalty, cleaned and placed within one club-length of the spot where it lay, not nearer the hole. Penalty for breach of local rule: Match play – Loss of hole; Stroke play – 2 strokes.
- On any hole(s) designated by the Handicap Committee and the Club Manager as subject to 'Preferred Lies', a player may, in the player's own fairway, move the ball without penalty up to six inches, not nearer the hole, using a golf club. Touching by hand, lifting or cleaning the ball is not permitted. Penalty for breach of local rule: Match play – Loss of hole; Stroke play – 2 strokes.

Immovable Obstructions

Interference by an immovable obstruction (Rule 24-2) occurs when a ball lies in or on an obstruction, or when the obstruction interferes with a player's stance or the area of his intended swing. Intervention on the line of play is not, of itself, interference under this Rule. A player may take relief without penalty, within one club length of the nearest point of relief, not nearer the hole. Immovable obstructions include the following:

- Electrical junction/control boxes anywhere on the course,
- Protective raised ropes on the 2nd, 6th, 7th, 9th and 11th holes,
- Sprinkler heads and drainage gratings anywhere on the course.

Yellow cart ropes placed across some fairways are movable obstructions.

Provisional Ball

Specifically on the 3rd hole, if a ball is believed to be lost in the water hazard short of the green, to save time a provisional ball may be played, under penalty of one stroke, as nearly as possible at the spot from which the original ball was last played (Rule 27-2), without declaring the original ball lost. If the original ball is subsequently found, the player must either play the original ball as it lies, or continue with the provisional ball in play.

Distance-Measuring Devices

For all play at this course, a player may obtain distance information by using a device that measures distance only. However, if, during a stipulated round, a player uses a distance-measuring device that is designed to gauge or measure other conditions that might affect his play (e.g., gradient, wind-speed, temperature, etc.), the player is in breach of Rule 14-3, for which the penalty is disqualification, regardless of whether any such additional functions are actually used.

The Golf Club at Cedar Creek

Local Rules – Short Version

Abnormal Ground Conditions / Ground Under Repair

One club-length relief not nearer the hole from:

- French drains,
- Water diversion ditches on holes 2, 7 and 18,
- The Memorial Garden area to the right of the 7th green.

Ball played as it lies, except, on the fairway, (a) 'Cart Path Only' holes, lift, clean & place within 1 club-length, or (b) six inches relief with the club only, dependent upon the weather and course conditions.

Immovable Obstructions

One club-length relief not nearer the hole (Rule 24-1) from:

- Electrical junction/control boxes anywhere on the course,
- Protective raised ropes on holes 2, 6, 7, 9 and 11,
- Sprinkler heads and drainage gratings anywhere on the course.

Yellow cart ropes placed across some fairways are movable obstructions.

Provisional Ball

Hole 3, provisional ball is permitted if ball is believed to be in the water hazard.

Distance-Measuring Devices

Player may use a device that measures distance only.

The Ladies' Club will be sponsoring a hole during the Rally for a Cure Tournament, Cindy Niland who also belongs to the Aiken Club won the Club Championship for the ladies' division at that club. The Ladies 18 Hole Club is hosting an Invitational on October 30. Currently there are 80 players signed up and with the generosity of sponsors will be donating \$700 to Hook A Kid On Golf. The Ladies 18 Hole Club is also encouraging the ladies to "Adopt-A-Hole" to help repair divots, clean up cigarette butts, broken tees, etc. once a month.




